NATKD CTF Sparring rules as follows for Individual and Team: Blood is a disqualification at center judge discretion. Mouthpiece and cup required. Foam pads and head gear mandatory. Shin pads recommended. NO MMA style hand pads.

Scoring as follows:

1 point controlled hand technique to target area of body

2 points controlled foot technique to target area of body

2 minute rounds running score Ties will be sudden victory

Any and all center judge decisions are final

- 5.No attempting to influence scoring or judging by coercive vocalizing for a perceived point for an executed technique.
- 6.No excess contact permitted as determined by judges which may result in an immediate disqualification and/or removal from premises.
- 7.All will be respectful/supportive of all students regardless of rank or style.
- 8.All will be respectful/supportive of all officials and tournament staff, as well as public and personal property of others.
- 9.Cheering is permitted if it is respectful and not obnoxiously loud. Social media posting is permitted but must be respectful.
10. All competitors will be held to the highest standard of excellence with zero tolerance for unsafe or unsportsmanlike behavior
11. I agree to all terms and conditions set forth and agree to abide by all codes of conduct understanding that I may be asked to leave if deemed appropriate
